

## Local Government Act 1972 – Section 214 & Schedule 26 Cemeteries and Crematoria Local Authorities' Cemeteries Order 1977

Great Shelford Parish Council, being the Burial Authority for the Parish of Great Shelford for the purposes and having the function given to it by, the provisions of the above mentioned Act and Order, at its meeting of 12<sup>th</sup> October 2022 fixed and settled the following fees in connection with burials in Great Shelford Cemetery.

The person to be interred or in respect of whom the right is granted must be before their death, a past or present inhabitant or parishioner of the Parish of Great Shelford or in the case of a still-born child, where one of the parents is, or at the time of interment was, such an inhabitant or parishioner.

In all other cases, the Exclusive Right of Burial and Interment fees will be doubled.

### PART 1: EXCLUSIVE RIGHT OF BURIAL (plot purchase)

For 99 years in an earthen Grave 2 metres by 1 metre.....	£280.00
For 99 years in an earthen Grave, double depth.....	£460.00
For 99 years of cremated remains in an earthen grave 600mm by 600mm.....	£130.00

### PART 2: INTERMENT

Interment.....	£230.00
Interment of ashes .....	£130.00

- The fees indicated above do not include the digging of the grave.
- Fees for child interments or cremations are no longer to be charged to the family. Local Authority fees will be met by Government funding.

### PART 3: MONUMENTS, GRAVESTONES, TABLETS & MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave in respect of which the exclusive right of burial has been granted:

A headstone not exceeding 1.35 metres in height.....	£230.00
A vase or tablet not exceeding 750mm in height.....	£230.00
A cross of hardwood not exceeding 600mm in height and 610mm in width. ....	£230.00
A flat kerb not exceeding 7 inches x 3 inches.....	£250.00
A flat tablet not exceeding 300mm by 400mm. ....	£250.00
<b>The Memorial Garden</b> – Small stones size not to exceed 35cm by 40cm placed flat in the ground, at ground level. ....	
£220.00	
(The fees indicated in Part 3 above include the first inscription)	
Each additional inscription thereafter.....	£145.00

Headstones may not be erected until at least six months after the date of burial.

No memorial may be erected until the design and inscription have been approved by the Parish Clerk. No alterations may be made to any existing memorial without consent from the Clerk.
